It is notified for the information of all concerned that it has been decided that University of Balochistan will conduct physical classes for a period of 45 days commencing from 21st September, 2020 to overcome the burden of semester affected during Covid-19 for all enrolled students (BS/Masters) including all Sub-Campuses and Affiliated Colleges.

Moreover, fall semester will be commenced from 16th November, 2020 and will end on 09th January, 2021 positively. It is further added that due to Covid-19 mid-term examination for the two semesters during 2020 is skipped and only terminal examination shall be conducted.


The mode of examination will be;

- i. The question paper shall consist of two parts
 - Part-I 30% weightage of mid-term exam.
 - Part-II 40% weightage of final term exam respectively.
 - Remaining 30% will be counted for assignments and presentations.

The Chairpersons/ Directors/ Incharges shall provide complete workload through the concerned dean for visiting faculty for those specialized subjects, where faculty is required from outside University.

Furthermore, the Deans of the Faculties will provide the time-tables details of all semesters and programs of their concerned departments/institutes/centres to DIT for managing faculty-wise classrooms through software program.
